

• "I Hate When Politics Is Injected Into Science': Text Messages of Top Scientists Shed Light on COVID Origin Response"

"A new report released by Republican members of the House Select Subcommittee on the Coronavirus Pandemic includes new evidence that a group of scientists who received funding from the National Institute of Allergy and Infectious Diseases (NIAID), conspired to dismiss the origin of the pandemic in order to protect China. The text messages were exchanged between authors of the Proximal Origin paper, initiated by then-NIAID Director Anthony Fauci, which had the explicit purpose of dismissing the lab leak theory for the pandemic's origin. The Proximal Origin paper, which declared that no "laboratory-based scenario is plausible," became one of the most cited science papers of all time and was prominently used by Dr. Fauci as proof that the COVID-19 virus came from nature."

"COVID Vaccines Show 24 Times More Adverse Reactions Than Others"

"The latest report on adverse reactions to vaccines in <u>Western Australia</u> has revealed that COVID-19 vaccinations have 24 times the rate of adverse reactions in the state compared to all other vaccines. According to the state's vaccine safety surveillance report (pdf), COVID-19 vaccines showed that for every 100,000 COVID-19 vaccines administered, 264 adverse events following immunisations (AEFIs) were recorded. For all other vaccinations, 11.1 AEFIs were recorded, making the COVID-19 vaccines 23.8 times more likely than non-COVID-19 vaccines to result in adverse events."

• "Subclinical Heart Damage More Prevalent Than Thought After Moderna Vaccination: Study"

"Damage to the heart is more common than thought after receipt of Moderna's COVID-19 booster, a new study indicates. One in 35 health care workers at a Swiss hospital had signs of heart injury associated with the vaccine, mRNA-1273, researchers found. "mRNA-1273 booster vaccination-associated elevation of markers of myocardial injury occurred in about one out of 35 persons (2.8%), a greater incidence than estimated in meta-analyses of hospitalized cases with myocarditis (estimated incidence 0.0035%) after the second vaccination," the researchers wrote in the paper, published by the European Journal of Heart Failure."

• "CDC Used Journal to Promote Masks Despite 'Unreliable' and 'Unsupported Data': New Analysis" "A new analysis of studies in the Centers for Disease Control and Prevention's (CDC) flagship scientific journal found the agency promoted the effectiveness of masks using unreliable data with conclusions unsupported by evidence. The preprint, published July 11 on MedRxiv, found the CDC's

Morbidity and Mortality Weekly Report (MMWR) made positive findings about the efficacy of masks 75 percent of the time, despite only 30 percent of studies testing masks, and less than 15 percent having "statistically significant results." No studies were randomized, yet the CDC in over half of their MMWR studies, made misleading statements indicating a causal relationship between mask-wearing and a decrease in COVID-19 cases or transmission, despite failing to show evidence of mask effectiveness."

#### • "Scientists Investigating 'Long Vax' Symptoms Linked to COVID Shot"

"Scientists at Yale and Harvard say they are starting to pay attention to conditions that may be caused by COVID-19 vaccines, which has been dubbed "long vax" in media outlets this week. "You see one or two patients, and you wonder if it's a coincidence," Dr. Anne Louise Oaklander, a neurologist and researcher with Harvard Medical School, told the Science website. "But by the time you've seen 10, 20 [patients]," she added, "where there's smoke, there's fire." They said that symptoms of the so-called long vax, a term that was spawned from "long COVID," can mimic those of long COVID, including fatigue, headaches, abnormal heart rate, and blood pressure issues."

According to a paper published in the International Journal of Molecular Sciences on June 22, COVID-19 mRNA vaccines, by mode and action, are gene therapy products and should adhere to different regulatory standards. Yet U.S. and European regulatory agencies have not classified COVID-19 mRNA vaccines as gene therapy products, which has allowed them to be regulated as vaccines against infectious diseases instead of being subjected to the more stringent regulation of GTPs."
