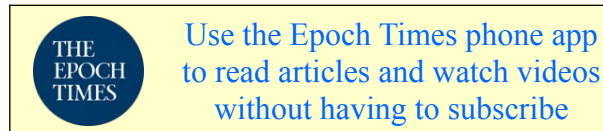

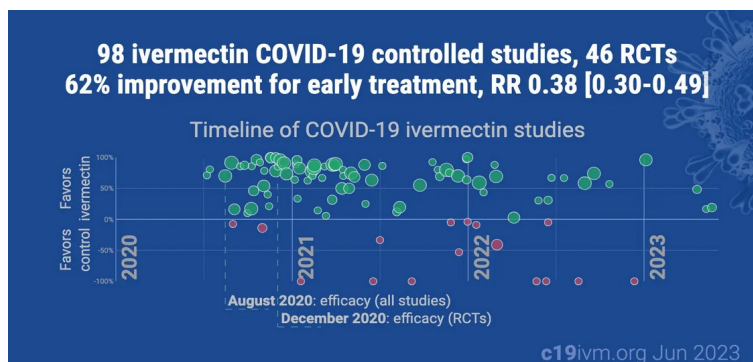

- “Cardiologist Calls on Australia’s Medical Regulator to Suspend COVID Vaccine Mandates”**

- **“Pulling Back the Curtain: mRNA Lipid Nanoparticle Design Created Potential for Clotting and Triggering Immune Overdrive”**

“Previously: We introduced how the FDA relaxed the rules for mRNA vaccines compared to mRNA therapies. We also discussed the available data for LNP distribution throughout the body based on animal testing and the fact that human testing was not done. Finally, we discussed the lack of biodistribution data on the mRNA and its encoded spike protein contained in the COVID mRNA vaccine. We will now discuss how the LNPs are constructed and how they behave in the body. The engineering of these molecules must keep the capsule stable during transit but also allow it to dissolve quickly once injected.
