• "Report shows Australia's excess mortality rate has risen to levels not seen since"

"A new study released this week has shown Australia is experiencing its highest excess mortality rates in over 80 years. According to the Actuaries Institute, there was a 12 per cent increase in excess deaths in 2022. Of the additional 20,000 deaths, 10,300 were attributed to Covid-19 — with another 2,900 deaths where the virus was a contributing factor. The remaining 6,600 excess deaths were not related to Covid-19, with ischaemic heart disease and cancer being the most common causes, leading to 2,020 and 970 excess deaths respectively. Karen Cutter, the spokesperson for the Institute's Covid-19 mortality working group, emphasised that the increase of 20,000 deaths is extraordinary and has not been witnessed since World War II."
