

"Researchers Find Pfizer Excluded Clinical Trial Deaths From FDA COVID Vaccine EUA Request"

"To obtain emergency use authorization (EUA) for its COVID-19 vaccine, Pfizer and BioNTech submitted a data package in 2020 to the U.S. Food and Drug Administration (FDA) so the agency could evaluate the safety and efficacy of its vaccine. A recently published peer-reviewed study by the DailyClout Pfizer/BioNTech Documents Investigations Team suggests Pfizer excluded known deaths in the vaccine arm of its clinical trial from its data filing and withheld information from the agency that could have resulted in a denial of EUA. Delayed reporting of the subject deaths into the Case Report Forms (CRFs) obscured the cardiac adverse event signal and allowed Pfizer/BioNTech's request for EUA to proceed unchallenged, according to the study."

• "Every Additional 4 Years in Age, Risk of Dying Per COVID-19 Injection Doubles: Study"

"The Sept. 17 study, published by the nonprofit research organization CORRELATION, analyzed COVID-19 vaccinations and all-cause mortality data from 17 equatorial and Southern Hemisphere countries...By dose four, or the second booster, the risk of death per injection reaches 5 percent, or an average of 1 death per 20 injections. "The older the people, the greater the risk of dying [from COVID-19 vaccines] and the more deaths there are," Denis Rancourt, an author of the study, said in an Oct. 12 interview with investigative journalist Sonia Elijah. The 1-in-20 risk of death among the elderly population is a "massive risk of dying from a medical intervention that's normally intended to help people.""

• "Hydroxychloroquine Reduces COVID-19 Mortality, Study Finds"

"People who took hydroxychloroquine in combination with another drug while hospitalized with COVID-19 were less likely to die than those who didn't, according to a new study. Hydroxychloroquine, which is widely used against malaria and arthritis, was given to hundreds of patients hospitalized with COVID-19 in Belgium. Thousands of others didn't receive the drug. Researchers examined records from 352 adults hospitalized in AZ Groeninge Hospital in Kortrijk, Belgium. All patients tested positive for COVID-19 or had results from CT scans that suggested COVID-19 was present. Patients received hydroxychloroquine alone or with azithromycin, an antibiotic. They were scanned before and after treatment."

• "COVID-19 Cases Become Milder, With Upper Respiratory Focus, Doctors Say"

"COVID-19 symptoms have now become more mild and are nearly indistinguishable from allergies or the common cold, often affecting the upper respiratory tract, a number of doctors have said. They note that some of the notable COVID-19 symptoms, including a cough or a loss of taste or smell, are less common among patients. "It isn't the same typical symptoms that we were seeing before. It's a lot of congestion, sometimes sneezing, usually a mild sore throat," Dr. Erick Eiting, vice chair of operations for emergency medicine at New York's Mount Sinai, told NBC News on Sept. 16."
