

- "10 Types of Misinformation in Peer-Reviewed COVID-19 Paper Decrying Misinformation"

 "Recently, one of America's leading medical journals, the Journal of the American Medical
 Association, published a peer-reviewed paper studying the propagation of "COVID-19 misinformation
 on social media by physicians in the US." The article is riddled with major errors, labels true
 information as misinformation, and "exemplifies how relying on the government to decide what's true
 versus false can be so problematic and can cost lives," argues Dr. Tracy Beth Høeg, a physician
 epidemiologist. She works in private practice and also has a position at the department of biostatistics
 and epidemiology at the University of California—San Francisco. "It's very disturbing that [this paper]
 passed through the peer review process and was published," Dr. Høeg says."

- "The U.S. Centers for Disease Control and Prevention (CDC) has halted the collection of COVID-19 vaccine adverse events reports through the agency's V-Safe page, even after millions of Americans have reported such events. When visiting the V-Safe page, a message shows: "Thank you for your participation. Data collection for COVID-19 vaccines concluded on June 30, 2023. If you have symptoms or health problems following your COVID-19 vaccination that concern you, please contact your healthcare provider. You can also report to the Vaccine Adverse Event Reporting System (VAERS)."... The CDC says that it closed enrollment in V-safe on May 19, as the program was "developed specifically for COVID-19 vaccines." According to the agency, it is "developing a new version of v-safe which will allow users to share their post-vaccination experiences with new vaccines.""

• "People Rarely Transmit COVID-19 Before Experiencing Symptoms: Lancet Study"

"In a blow to the COVID-19 "silent spreader" narrative that has been used to push for universal masking, including controversially among schoolchildren, a recent study published in The Lancet suggests that people who are non-symptomatic rarely have the ability to infect others. Silent transmission is the idea that those who are infected with COVID-19 but show no symptoms can still spread the virus to other people. While all relevant studies show that presymptomatic and asymptomatic "silent spreaders" account for some proportion of infections in other people, the degree of silent transmission is less clear."

• "Bivalent Booster Protection Against Hospitalization Drops to Near-Zero: CDC Data" "Protection against hospitalization from bivalent COVID-19 vaccines quickly dropped over time,

according to U.S. Centers for Disease Control and Prevention (CDC) data presented on Sept. 12. For adults aged 18 to 64 with healthy immune systems, the protection from the old monovalent shots was just 15 percent, according to data from the CDC's VISION network. A bivalent shot increased the protection to 61 percent but that shielding fell to 15 percent between 60 and 119 days and to negative one percent beyond 120 days, CDC researchers found."

- "US Doctors' Group Says All Mask Mandates 'Must Be Rescinded"

"A medical group issued a warning this week about wearing masks for respiratory viruses such as COVID-19, arguing that studies show they don't prevent their spread and instead violate patients' rights to informed consent. "As mask mandates are contrary to the fundamental medical principle of informed consent, all masking mandates currently in place must be rescinded, and no future mandates should be imposed," the Association of American Physicians and Surgeons, a longtime conservative-aligned medical group, said in a statement, likely responding to recent hospital mask mandates that were reimposed in August. The group made reference to research, including a recent paper from the Cochrane Database of Systematic Reviews that concluded numerous studies "did not show a clear reduction in respiratory viral infection with the use of medical/surgical masks," while there "were no clear differences between the use of medical/surgical masks compared with N95/P2 respirators in healthcare workers when used in routine care to reduce respiratory viral infection.""
