

"Australian Government Establishes Net Zero Authority"

"The Albanese Labor government has introduced a law to set up a Net Zero Authority in Australia to support the country's transition to net zero. The Labor government is pumping \$189.3 million (US123.5 million) of taxpayer funds into the initiative to resource the authority. The Net Zero Economy Authority Bill 2024 (pdf) aims to promote an "orderly and positive economic

transformation" as the "world decarbonises. .Mr. Albanese said the Net Zero Economy Authority will play a role in one of the most significant economic events in Australia's history and position the country as a renewable energy superpower."

• "Australian Government Introduces Mandatory Climate Reporting"

"The Albanese government has introduced laws to mandate climate reporting for large companies from early 2025, intending to spur greater investment in clean energy and assist investors and companies to "manage climate risks." The Treasury Laws Amendment (Financial Market Infrastructure and Other Measures) Bill (pdf) was introduced into the Australian House of Representatives on March 27. The bill includes new compulsory climate reporting requirements for major companies. Additionally, it establishes a framework to protect our financial market infrastructure during crises. The law starts with Australia's largest companies but then extends to encompass medium and smaller companies over time."

 "Pfizer and Moderna COVID Vaccines' Efficacy Exaggerated, Effectiveness 'Well Below' 50 Percent, Researchers Say"
